#### Location

This site is located adjacent to Rednal Industrial Estate approximately 2.5 miles north east of the A5 Trunk Road (Queens Head Junction). The industrial estate is located approximately 6 miles east of Oswestry and 17 miles north of Shrewsbury.

The M53 & M56 Motorway intersection is situated approximately 35 miles north, accessed via the A483 and A55 which in turn provides access to Liverpool (50 miles) Manchester (70 miles) and North Wales

The M54 Motorway (Junction 7) is located approximately 25 miles south which provides motorway access to Telford (30 miles), Wolverhampton (50 miles) and Birmingham (65 miles).

### Description

The former airfield comprises predominantly hardstanding which could be suitable for a variety of uses. (Subject to planning).

#### Terms

Available on request. Subject to plot size requirements, proposed use and enabling works required prior to letting.





#### Services

Three phase electricity is available within close proximity to the site.

Mains water and drainage is available, albeit subject to proposed uses and connection charges etc.

#### Planning


